GENERAL RULES AND INSTRUCTIONS TO THE INTENDING APPLICANTS

- 1.0. The empanelment of Consultants, Contractors, Suppliers and Service Providers are proposed for the Civil, Electrical, Interior works and other allied works of routine nature in the Branches and offices coming within the jurisdiction of Canara Bank Circle Office Hubballi. Generally, the routine works of the Bank are awarded/procurements are made on calling competitive tenders/quotations from the empanelled contractors/suppliers. However, the Bank has the right to award the work/procure supply from any of the empanelled agencies, depending on the exigencies of the work and also opt for open tendering process for any particular work, depending on the nature & magnitude of the work.
- 2.0. This document consists of the following:
- 2.1. Notice inviting applications for empanelment of consultants, contractors, suppliers/vendors and service providers.
- 2.2. General rules and instructions to the intending applicants.
- 2.3. Scope, cost wise sub-classification and eligibility criteria for each category.
- 2.4. Application format for empanelment.
- 3.0. The complete document as detailed above, complete in all respects, should be submitted by the intending applicants within the stipulated date and as per the instructions given in the Notice inviting applications. The details of the applicants and their experience shall be furnished in the prescribed "Application Format" only. Wherever required and if the space provided is not sufficient, particulars can be furnished in Annexure but such details shall be clearly mentioned in the respective columns of the Application Format. Applicant shall enclose latest copies of brochures and technical documentation giving additional information about the applicant. Each page of the document shall be duly signed by the Applicant or their authorized representative.

The checklist given along the application should be duly filled up and should be submitted along with applications. The applications without checklist are liable for rejection.

- **4.0.** The Consultants/Contractors/Suppliers/Service Providers, who intend to apply for more than one category, have to apply for each category using separate application forms.
- **5.0.** No costs incurred by the applicant in applying, in providing necessary clarifications or attending discussions, conferences or site visits will be reimbursed by the Bank.
- **6.0.** Documentary proof with respect to the details furnished in the application form regarding eligibility criteria shall be furnished along with the application form. In this regard, copies of the work order and completion certificate and/or such documents shall be submitted. Incomplete applications or applications without proper proofs for establishing their credentials will be summarily rejected and no correspondence will be entertained in this regard.

- **7.0.** If the application is made by a partnership firm, a certified copy of the partnership deed, current address of the firm and the full names and current addresses of all the partners of the firm shall also accompany the application.
- **8.0.** If the application is made by a limited company, it shall be signed by a duly authorized person holding the power of attorney for signing the application in which case certified copies of the power of attorney and the certification of incorporation, Memorandum of Articles of Association shall accompany the application.
- **9.0.** The empanelment shall be made for a specific category as per the application received supported by documentary proofs. For different category the applicant has to apply using separate application form.
- 10.0. The evaluation will be based on the experience of the consultants/ contractors / suppliers/ service providers and their financial capabilities and may also include inspecting the works furnished by them for which, necessary co-ordination shall be made by them. Based on the details furnished and inspection of works, eligibility criteria, the consultants/ contractors/ suppliers/ service providers will be empanelled. Decision of the Bank regarding selection / rejection for empanelment will be final and binding and no further correspondence will be entertained. Only the empanelled contractors will be informed by post.
- **11.0.** If, information and details furnished by applicants are found to be false at any time in future or any information withheld, which comes to the notice of the Bank at a later date, the empanelment of such applicant will be cancelled immediately.
- **12.0.** Applications received after the due date and time is liable for rejections.
- 13.0. For the category of Contractors, the applicants having their office in the state of Karnataka, Telangana, Andhra Pradesh and Maharashtra will only be considered and for consultants/ suppliers/service providers category, the applicants having their office in Karnataka state will only be considered. The applicant has to submit valid proof of address from respective authorities should be submitted (Rental agreement as proof will not be accepted). The empanelment shall be valid up to three year from the date of issue of empanelment letter under normal circumstances provided there is no disciplinary/ de-empanelment clause raised against them.
- **14.0.** Canara Bank reserves its right to reject any / or all the applications without assigning any reasons whatsoever.
- 15.0. MSE's (Micro and Small Enterprise) / NSIC / KVI etc. are exempted from paying the processing fee of Rs.590/- for which the concerned enterprise needs to provide necessary valid certificates / documentary evidence of the said work. For MSE's, Govt. of India provision shall be considered while evaluating the tender.

- 16.0. Firms should submit an undertaking (on their letter head) that they have not been "Black Listed" by any of the Govt. Authority or PSUs/PSBs duly signed by authorized signatory with company seal.

- 18.0. When the misconduct of a firm or its continued poor performance justified imposition of ban on business relation with the firm or it's Blacklisting, this action will be taken after due consideration of all factors and circumstances of the case. SCOPE, COST WISE SUB-CLASSIFICATION AND ELIGIBILITY CRITERIA FOR CONSULTANTS

A.SCOPE-OF-WORK

The scope of work for the **Architectural Consultants** include designing interior layout plans for the branch/offices of the Bank, providing the specifications of the materials, assisting the Bank in finalizing the contractor and supervision of the interior works ,if sought by the Bank. Some time the panel architects services will also be availed for planning, designing and execution of extension of Banks own buildings involving the approval for the same from the local Authorities.

The services of **Civil Engineering/ Structural consultants** will be used for planning, estimation and execution, maintenance of Civil works of Bank's own buildings, measurement of carpet area of the Branch/office premises.

The services of **Electrical consultants** will be used for planning and execution of the electrical works for the Bank branches/offices including procurement of electrical equipments like Generators, UPS, Transformers and other allied items.

Generally, the routine interior works, Civil, electrical and air-conditioning works as detailed above are being carried out by the Bank's Engineers. The services of the consultants will be availed as and when it is required depending on the magnitude and specialization required for the project.

It is proposed to avail services of consultants from the approved panel for the interior works costing up to Rs.50.00 lakhs, Civil works costing up to Rs.50.00 lakhs, Electrical works up to Rs.30.00 lakhs. However, the Bank has right to avail the services of any consultant from out side the panel depending on the circumstances.

The panel of **Civil Engineering Contractors** will be mainly used for civil engineering works like earthwork, masonry, plastering, RCC, concrete works, painting, flooring, plumbing & sanitary, water proofing, demolition works, structural steel fabrication, woodwork (doors and windows only) and other allied works for branches, Bank owned residences and offices of the Bank.

The panel of **Electrical Contractors** will be mainly used for internal and external electrification, associated cabling, earthing, wiring for air-conditioners, UPS, laisoning with Reliance Energy, Tata Power, BEST or other state electricity board for obtention of additional power, breakdown repairs and other allied works for various branches/ offices of the Bank.

The scope of work of the Fire detection and alarm contractors mainly involves supply, installation, testing and commissioning of fire detection and alarm system for various

branches / Offices of the bank.

B. COST WISE SUB-CLASSIFICATION:

It is proposed to classify each category of contractors depending on their past performance, technical and financial capabilities of the contractor. The contractors empanelled under lower class/category will not be eligible to participate for the works of higher class/category. However, the contractors classified under higher class can participate for works under lower class.

The contractors empanelled under Class-D are allowed to quote only in the geographical jurisdiction of our Regional Offices where the contractor is stationed. The other class of contractors can quote for the works coming under the geographical jurisdiction of the Circle Office Hubballi.

He should have executed at least one single similar work costing not less Rs.10000.00 during the last one year.

The contractors empanelled under Class-D also should get the PAN number from Income Tax Authorities and GST number from Goods and Services Tax Department within 6 months from the date of empanelment failing which, they will not be allowed to quote for any further works.

SCOPE, COST WISE SUB-CLASSIFICATION AND ELIGIBILITY CRITERIA FOR SUPPLIERS/ VENDORS AND SERVICE PROVIDERS

The general eligibility criteria and cost wise sub-classification for the suppliers and service providers of Air-conditioners, Office furniture/ Modular furniture, Electrical Fixtures, Fittings and Equipments, UPS vendors, Electronic gadgets, Fire alarm, Burglar alarm, CCTV vendors, Fire extinguishers suppliers & Service providers (refilling), Security Items (strong room door, TRTL/ FRRC safe, Safe Deposit Lockers) supplier vendors is as under:-

- (c) One similar completed work costing not less than the amount equal to **80**% of the cost limit in the respective category.

- Except for Class-D, the contractors for other classes should
 - a) a Have well-established office in the respective centre with adequate Engineering staff
 - b) The applicant shall have the annual financial turnover of at least 30% the value of the class limit in the respective category during last 3 years ending with 31.03.2024. Applicant should submit copies of Audited/ Provisional Balance Sheets and tax return receipts.
 - c) The applicant should be an assessee of Income Tax and must possess GST Registration. Should submit copy of the Income Tax PAN, GST certificate with valid registration number. Submit solvency certificate from Nationalized/ scheduled bank issued within one year for an amount equal to the cost limit in the respective category.
 - d) Submit solvency certificate from Nationalized /Scheduled bank issued within one year for an amount equal to cost limit in the respective class.

All class of vendors must be Income Tax Assessee. The vendors empanelled under Class-D also should get the PAN number from Income Tax Authorities and GST number from Goods and Services Tax Department within 6 months from the date of empanelment failing which, they will not be allowed to quote for any further works.

SCOPE AND ELIGIBILTY CRITERIA FOR SERVICE PROVIDERS

PEST CONTROL SERVICES

• The service provider should have minimum 3 years experience in Pest Control service for all types of insects, rodents and snakes and should have completed servicing worth not less than Rs. 500000.00 and should have at least one single similar work costing not less Rs.100000.00 during the last one year prior to 31.03.2024.

The service provider should get the PAN number from Income Tax Authorities and GST number from Goods and Services Tax Department within 6 months from the date of empanelment failing which, they will not be allowed to quote for any further works.

HOUSEKEEPING SERVICES

- 1. For empanelment or short-listing of Housekeeping Agencies (PSA), the following criteria shall be applied. For this purpose **service providers** shall submit proof documents along with the application and those not submitting proof documents and/or not conforming to any of these parameters will not qualify for short listing:

- g) The applicant should have a valid certificate under EPF & Miscellaneous Provisions Act 1952 and the applicant should have been submitting EPF contribution online.
- h) The applicant must have valid PAN number & GST registration.
- i) The applicant should have Documents proving compliance of Minimum Wages Act 1948 and other Labour laws and rules.
- j) The applicant shall have the annual financial turnover of at least 30% the value of the class limit in the respective category during last 3 years ending with 31.03.2024. Applicant should submit copies of Audited/ Provisional Balance Sheets and tax return receipts.
- k) The applicant should be an assessee of Income Tax and must possess GST Registration. Should submit copy of the Income Tax PAN, GST certificate with valid registration number. Submit solvency certificate from Nationalized/ scheduled bank issued within one year for an amount equal to the cost limit in the respective category.
- l) Submit solvency certificate from Nationalized /Scheduled bank issued within one year for an amount equal to cost limit in the respective class.
- The service provider should have minimum 3 years experience in Housekeeping services and should have of area not less than 5,000 Sft or during the last one year prior to 31.03.2024.

The service provider should get the PAN number from Income Tax Authorities and GST number from Goods and Services Tax Department within 6 months from the date of empanelment failing which, they will not be allowed to quote for any further works.



PRIVATE SECURITY SERVICES AGENCIES

- 1. For empanelment or short-listing of Private Security Agencies (PSA), the following criteria shall be applied. For this purpose PSAs shall submit proof documents along with the application and PSAs not submitting proof documents and/or not conforming to any of these parameters will not qualify for short listing:
 - a) PSAs should be either registered companies or registered partnership firms for providing security guards services. PSAs should have the necessary clearance and valid License including that of the Office of the D.G.P. Karnataka to operate in the geographical jurisdiction of the Karnataka State.
 - b) PSAs should have obtained a license in accordance with section 4 and 7 of the Private Security Regulation Act 2005, Karnataka Private Security Agencies Rules, 2008. Registration with Directorate General of Resettlement will be given preference.
 - c) PSAs should have their own infrastructure for training their guards in Karnataka State.
 - d) PSAs should have credible Supervisory and Training Infrastructure and network.
 - e) PSAs should be an Income Tax assessee and should have submitted IT returns for the last three years.
 - f) PSAs should have audited Profit & Loss Accounts for the past three years and the annual turnover of the PSA in the last three years should atleast be 30% of the class limit.
 - g) PSAs should have Registration under Shops & Establishments Act. PSAs should have necessary registrations with Labour Department and other Govt. Departments for compliance of all statutory/Govt requirements applicable to security agencies.
 - h) PSAs should have a valid certificate from ESI Corporation and should have been allotted with a code number by the ESIC.
 - i) PSAs should have a valid certificate under EPF & Miscellaneous Provisions Act 1952 and the PSA should have been submitting EPF contribution online.
 - j) PSAs should have Documents proving compliance of Minimum Wages Act 1948 and other Labour laws and rules.
 - k) PSAs should have at least Two telephone numbers along with Mobile, fax/ Email facility at their branch office/head office in Karnataka or in the jurisdiction area of Hubballi Circle Office and the office should be manned 24 x 7.





- l) PSA should have minimum Three years of experience in providing Security Guards' services.
- m) PSA shall not be owned or controlled by any director or office/employee of the Bank or their relative having the same meaning as assigned under section 6 of the Companies Act 1956.
- n) The PSA should not have incurred loss in the last three years.
- 2. a) PSAs are required to furnish a copy of the Electronic Challan-Cum-Return (ECR) for EPF contribution for a Wage Month not older than two months prior to the application submission date.
 - b) PSAs are required to furnish a copy of the previous "Return of Contributions" (Form-5) submitted to the ESIC or a copy Electronic Contribution History Sheet submitted to the ESIC in case of online contribution.
 - c) PSAs are required to furnish a copy of the past Wage Slip, not older than three months, of any of their employees deployed as a Security Guard with any Principle Employment.
 - d) PSAs will be required to produce all original documents kept in his office for verification by authorized staff of Bank whenever they visit PSA's Office for inspection of training infrastructure and other credentials of PSA
