### Terms and conditions

- 1. The work will be awarded to L1 bidder.
- 2. The work should be carried out in co-ordination with furnishing and electrical contractors so that all the wirings are hidden and all the wiring works should be complete before closure of the partitions and completion of false-ceiling works.
- 3. The allotted work should be complete in all respects within 15 days from the date of issue of Work Order. If the above mentioned works are not completed within the stipulated time, then penalty of Rs. 500/- per day will be levied on the vendor.
- 4. The vendor should make their own arrangements for stay of the labours and no claim will be entertained in this regard by the Bank.
- 5. This is a short notice limited tender and only our empanelled vendors can participate in the tender.
- 6. Retention Money Deposit amount of 10% of the base amount of the final bill will be deducted at the time of final payment which will be released within fourteen days after completion of defect liability period of 1 year from the date of payment. However, the amount can be released upon submitting the Performance Guarantee of the amount equal to the base amount for the entire contract for that particular firm.
- 7. The amount quoted should be exclusive of GST amount which shall be paid separately by Bank.
- 8. The applicant has to put seal and sign on all the pages of the tender document.
- 9. The contractors can make use of the available facilities at site like, electricity; water etc, with the prior approval of the Bank.
- 10. Any damage caused to the equipment, furniture, fixtures, decor of the office etc shall be rectified by the contractor at their own cost or the cost of the damages, as decided by the Bank, will be recovered from the contractor.
- 11. Contractor shall note that no additional work is to be carried out without the written order from the Bank.
- 12. The detailed specifications for the usage of the components are attached with this tender document.
- 13. In the event of any disputes, the parties have agreed to settle the same amicably between them, failing which the same will be referred to an independent Arbitrator as may be mutually agreed between the bank and contractor as per the Indian Arbitration Act.
