The document submitted without the prescribed fee will be summarily rejected. However, those who have exemption certificate from NSIC/Similar Government authorities as per provision of MSME Act will be exempted from application fee, subject to the submission of valid document/certificate to that effect.

The duly completed document in the prescribed format with all supporting documents shall be sealed in a cover and super scribed as 'Application for EMPANELMENT of (<u>Category Name</u>)' and shall be submitted to the above mentioned office of CANARA BANK <u>on or before 29.09.2020 up to 3.00 PM.</u> Separate application forms are to be submitted for different categories.

The Bank reserves the right to accept or reject any or all the applications without assigning any reasons thereof and their decision of selection will be final.

GENERAL RULES AND INSTRUCTIONS TO THE INTENDING APPLICANTS

- 1. The empanelment of suppliers is proposed to supply the office materials for our branches and offices coming under the Circle Office. Generally, the procurements are
- 9 made on calling competitive tenders/quotations from the empanelled suppliers. However, the Bank has the right to procure supply from any of the empanelled Vendors, depending on the exigencies of the work.
- 2. The complete document as detailed above, complete in all respects, should be submitted by the intending applicants within the stipulated date and as per the instructions given in the Notice inviting applications. The details of the applicants and their experience shall be furnished in the prescribed <u>"Application Format"</u> only. Wherever required and if the space provided is not sufficient, particulars can be furnished in Annexure but such details shall be clearly mentioned in the respective columns of the Application Format. Applicant shall enclose latest copies of brochures and technical documentation giving additional information about the applicant. Each page of the document shall be duly signed by the Applicant or their authorized representative.

The checklist given along with the application should be duly filled up and should be submitted along with applications. The applications without checklist are liable for rejection.

- 3. The Suppliers, who intend to apply for more than one category, have to apply for each category using separate application forms along with separate Demand draft and submit in individual covers super scribing the category of work applied for in the envelope.
- 4. No costs incurred by the applicant in applying, in providing necessary clarifications or attending discussions, conferences or site visits will be reimbursed by the Bank.
- 5. Documentary proof with respect to the details furnished in the application form regarding eligibility criteria shall be furnished along with the application form. In this regard, copies of the work order and completion certificate and/or such documents shall be submitted. Incomplete applications or applications without proper proofs for establishing their credentials will be summarily rejected and no correspondence will be entertained in this regard.
- 6. The authorized person of the firm/company shall sign in all the pages of the application with seal of the company/firm.
- 7. If the application is made by a partnership firm, a certified copy of the partnership deed, current address of the firm and the full name and current address of all the partners of the firm shall also accompany the application.
- 8. If the application is made by a limited company, it shall be signed by a duly authorized person holding the power of attorney for signing the application in which case certified copies of the power of attorney and the certification of incorporation, Memorandum of Articles of Association shall accompany the application.

- 9. The evaluation will be based on the experience of the suppliers and their financial capabilities. Based on the details furnished, eligibility criteria, the suppliers will be empanelled. Decision of the Bank regarding selection / rejection for empanelment will be final and binding and no further correspondence will be entertained.
- 10. If, information and details furnished by applicants are found to be false at any time in future or any information withheld, which comes to the notice of the Bank at a later date, the empanelment of such applicant will be cancelled immediately.
- 11. Applications received after the due date and time is liable for rejections. If any application sent by Post/Courier and if the said document reaches after the due date and time specified above, the application will not be considered.
- 12. The Suppliers having their office in the geographical jurisdiction of the Circle office Zone wise as mentioned above will only be considered. The empanelment shall be valid for a minimum period of three years subject to review of performances.
- 13. Canara Bank reserves its right to reject any / or all the applications without assigning any reasons whatsoever.
- 14. Please note that all the documents requested should be arranged in the same order as mentioned in the checklist for each Annexure with proper numbering.

2.SCOPE OF WORK:

It is proposed to empanel the suppliers of Office ready furniture items for the anticipated procurements for the branches/offices of the Bank. The quotations will be obtained through authorized dealers/OEM.

A. Note Counting Machines

The Suppliers should have minimum of five year experience in the activity of supply and maintenance of Loose / Value Note counting machine and Bundle/ Section note counting machine capable of detecting suspected counterfeit notes as per latest RBI guidelines. The machine should be of reputed brand and have dealer and service networks in the Pune city and other areas coming under jurisdiction of Pune circle.

The model quoted by the supplier should have been released /operational in the market for at least 12 months.

B. Jewel weighing machine

The Supplier of the jewel weighing machine (with single USB port) should be in field for more than five years, the items should be of reputed brands and the branches should also be established in the field for more than five years. They should have dealers and service networks in the Pune city and other areas coming under jurisdiction of Pune circle. Calibration and Stamping have to be taken care of.

<u>C.</u> UPS, Stabilizer & Inverter

UPS, Stabilizer & Inverter provider shall be original manufacturers/ suppliers of the above items having wide dealer and service network in the geographical Jurisdiction of Circle Office, Pune above mentioned offices of the Bank. They should be established in this field for minimum 5 years.

D. Water Dispenser

The scope of work involves supply, installations and maintenance of the machines, carrying out repair work etc. The Supplier who has executed similar type of works for Government department (Central/State), Autonomous bodies, financial Institutions, Public sector banks will be given preference (as per the eligibility conditions)

Similar works means all original works, alterations and modifications involving supply, installation and testing of Water Dispenser and other related works for branches/Offices of the bank.

- In case of a company or Limited Liability Partnership, the beneficial owner is the natural person(s), who, whether acting alone or together, or through one or more juridical person, has a controlling ownership interest or who exercises control through other means. Explanation—
 - a. "Controlling ownership interest" means ownership of or entitlement to more than twenty-five per cent. of shares or capital or profits of the company;
 - b. "Control" shall include the right to appoint majority of the directors or to control the management or policy decisions including by virtue of their shareholding or management rights or shareholders agreements or voting agreements;
 - 2. In case of a partnership firm, the beneficial owner is the natural person(s) who, whether acting alone or together, or through one or more juridical person, has ownership of entitlement to more than fifteen percent of capital or profits of the partnership;
 - 3. In case of an unincorporated association or body of individuals, the beneficial owner is the natural person(s), who, whether acting alone or together, or through one or more juridical person, has ownership of or entitlement to more than fifteen percent of the property or capital or profits of such association or body of individuals;
 - 4. Where no natural person is identified under (1) or (2) or (3) above, the beneficial owner is the relevant natural person who holds the position of senior managing official;
 - In case of a trust, the identification of beneficial owner(s) shall include identification of the author of the trust, the trustee, the beneficiaries with fifteen percent or more interest in the trust and any other natural person exercising ultimate effective control over the trust through a chain of control or ownership.
